## SECTION 4. First aid measures

### 4.1. Description of first aid measures

#### Inhalation:

Air the area. Move immediately the contaminated patient from the area and keep him at rest in a well ventilated area. If you feel unwell seek medical advice.

#### Direct contact with skin (of the pure product):

Take contaminated clothing Immediately off.

Eliminate all unguarded flames and possible sources of ignition. No smoking.  
Provision of sufficient ventilation.  
Evacuate the danger area and, in case, consult an expert.
